Re: Dues Invoice and Registration

We appreciate your interest in support as a Nutmeg Corporate partner in 2022 for the Connecticut Oncology Association. The Connecticut Oncology Association is the sole professional support organization for Connecticut practicing oncologists and their practices, including practice administration. Our tax ID # is 06-1411082.

There are two possible levels for Corporate Partners: Nutmeg and Charter Oak. Most of our partners choose the Charter Oak level, to support the Connecticut Oncology Association in its initiatives without the need for funding requests later in the year.

The **Nutmeg** Corporate Dues for calendar year 2022 (January 1, 2022 – December 31, 2022) are \$5,000. The Charter Oak dues are \$8,000.

Corporate Partners (Nutmeg and Charter Oak) receive the following benefits. Please note that the Charter Oak benefits are significantly enhanced from prior years:

All Corporate Partners will receive email communications regarding notifications about CtOA meetings, advocacy, payment policy and issues, and updates on local, state and national issues of concern to the practices and patients dealing with cancer in CT.

Nutmeg Corporate Partners are able to send one representative at in person or online meetings (with a possibility of one more (space permitting at in person meetings) and with permission from the CtOA Executive Director – at a cost of \$50 upon registration) and have their name recognized on the www.CtOncology.com website, with a weblink attached to their name that goes to their corporate website.

Charter Oak Corporate Partners may register up to two representatives for each of the online or group meetings scheduled for CtOA membership (2 - 5 per year), and to register additional representatives (beyond the initial two), space permitting, at a cost of \$50 at registration.

Charter Oak Corporate Partners are recognized on the CtOA web site (www.ctoncology.com) by having their logo prominently displayed (to be supplied by the Corporate Partner), and are profiled in a separate highlighted page on the CtOA website with multiple links to corporate websites of their preference and a photograph and state contact information may be attached to the Corporate Partner Charter Oak Partner page.

Charter Oak Corporate partners will also be able to present Current news links and information for communication via the CT Oncology Association web site and will be recognized as Charter Oak members prominently with their corporate logo, as well as at each meeting.

In 2020,-2021 in-person meetings were suspended due to the pandemic, and the limitations placed upon our members for meetings and travel. We were able to hold several virtual meetings and continue to remain available to our Corporate Partners and members for advocacy and oncology landscape issues during the year. Our online presence and recognition of Corporate Partners through the CT Oncology Association website has been increased since 2020, to facilitate access between our members and partners.

As always, the Executive Director of CtOA remains readily accessible to address oncology advocacy and landscape issues at any point during the year. Our Board is being expanded, and we anticipate future CtOA Board activity in 2022.

Meeting calendars for recent years were full, with sessions with Aetna, ASCO, Practice benchmarking, MACRA/MIPS, oncology clinical pathways, personalized medicine, practice management updates, genomic testing, USP <797> and <800> pharmacy regulations, care management, and practice strategies for success. The CT Oncology Association was instrumental in state legislative discussions regarding Medicaid formularies, several pieces of state legislation affecting oncology patients, co-pay accumulators, national and state guidelines and pathways initiatives, national and state pharmacy regulation issues and changes, and Medicare national and local policies. We will be ending the unusual 2021 year with a virtual meeting with Bobbi Buell on Medicare Updates.

The 2022 meeting calendar is in development, and we look forward to working with you.
